Program Requirements for EO 13473: Priority Placement Program S

(Military sponsor's Fort Jackson orders issued/dated on or after 11 Sept 2009)

- You must be a spouse of an active duty military member.
- You were married to your sponsor prior to their report date to their new duty location
- You are a United States citizen.
- **Sponsor's PCS orders are issued/dated 11 Sept 09 or later to the new duty station verifies your eligibility for the military spouse preference program**
- Your military sponsor was reassigned on an unaccompanied tour with orders specifying the sequential assignment. The spouse may register for activities in the commuting area of the sequential assignment at any time during the sponsor's unaccompanied tour.

Required Documents:

- **Sponsor's Permanent Change of Station (PCS) orders must be issued/dated on 11 Sept 2009 or later.**
- Proof of marriage
- Copy of Resume from the *Army CPOL RESUMIX system* (**Registrants are required to have a resume on file in RESUMIX**). For link to Army Resume Building go to www.cpol.army.mil.
 - Resume must have sufficient information and be well written to be considered well qualified for positions.
 - Information on the resume will be used to determine which series and pay grade spouses will be placed in.

Program Requirements for EO 13473

Spouses are eligible to apply for jobs under EO 13473 eligibility status **for a maximum of 2 years from the date of the sponsors order were issued.**

Example:

ELIGIBLE FOR EO 13473: Sponsor's orders were issued on 1 Dec 2008. Spouse is still eligible to apply for jobs under EO 13473 until 1 Dec 2010.

INELIGIBLE FOR EO 13473: Sponsor's orders were issued on 1 Jan 2008. Spouse's eligibility expired on 1 Jan 2010 to apply for jobs under EO 13473.

Go to www.cpol.army.mil and post your resume on the *Army CPOL RESUMIX system*. Make sure you indicate on the Supplemental Data Sheet that your eligibility status is EO13473. You can self-nominate for internal jobs that are open to EO13473 candidates. Spouses can also complete the Military Spouse Wizard to determine if he/she is eligible for the Military Spouse EO 13473. - **Sponsor's Permanent Change of Station (PCS) orders**
